- a. Exhausted the Maximum Permissible Period of Non Use of a MobiKwik Wallet of 6 (SIX) Months OR 180 (ONE HUNDRED AND EIGHTY DAYS) Days from the Date of Registration AND OR
- b. Expiry of a Period of 3 (THREE) Years from the date on which the MobiKwik Wallet Account was registered.
- c. Expiry of a period of 180 (ONE HUNDRED AND EIGHTY DAYS) Days between the date of successful registration of the MobiKwik Wallet Account and the First Use of Services AND OR
